Ward 2 profile

- Population - nearly 40,000 - around 20,000 voters
- Number of businesses in BIAs - 700
- Density - almost 20,000 households
- Size - 1,293 ac, 523 ha, 5.23 km²
- Tenant to owner ratio - 3:1 - more than 70% rent

Harm reduction principles

- Everything we do in the Ward 2 office is centred around the principles of harm reduction -
 - Reducing harm for those most impacted
 - Avoiding practices that could increase harm
 - Building systems focused on support and care

My role as Ward 2 City Councillor

- Citywide **budget** deliberations
- **Strategic** decision-making
- 1/16 of the **vote** around the Council table
- **Consulted** on operational matters in Ward 2
- Responsible for stewarding **Ward 2 funding**

My role as Ward 2 City Councillor

- **Committee participation** - 45 Standing Committees, Sub-Committees, and Boards
- **19 are mandatory** - not including Ward 2 staples like the Hamilton Waterfront Trust, Art Gallery of Hamilton, and Hamilton Farmers' Market

My role as Ward 2 City Councillor

- **Most mandatory committees** of any member of City Council, including the Mayor
- Hamilton Police Services Board - I have an **additional obligation** to ensure that I am neither interfering in police operations or directing officers

My role as Ward 2 City Councillor

- Currently the Chair of 2 Boards and 1 Standing Committee -
 - Audit, Finance and Administration Committee
 - Hamilton Waterfront Trust Board of Trustees
 - Hamilton Farmers' Market Board of Directors

My role as Ward 2 City Councillor

- Currently the Vice Chair of 2 Sub-Committees -
 - Governance Review Sub-Committee
 - Grants Sub-Committee

Some of my responsibilities

- I represent Ward 2 but I also represent every Hamiltonian across the city as a member of Council
- I have to balance my responsibilities to individuals and communities
- I can't represent every resident on every issue

Some of my responsibilities

- I intend on doing my job ethically, which means -
 - Not interfering in the City's operations
 - Intervening as a policy maker
 - Governing with clarity and thoroughness
 - Centring equity in decision making
