# Harm reduction principles

- Everything we do in the Ward 2 office is centred around the principles of harm reduction -
  - **Reducing harm** for those most impacted
  - Avoiding practices that could **increase harm**
  - Building systems focused on **support and care**

# Ward 2 profile and information

- Population - 37,080 people - around 20,000 voters
- Density - almost 20,000 households
- Size - 1,293 ac, 523 ha, 5.23 km<sup>2</sup>
- Tax contributions - 76.6% renters and 23.4% owners
- Number of businesses in BIAs - 700+



# Ward 3 profile and information

- Population: 43,195, of which 34,000+ are voting age
- Density - almost 20,000 households
- Size - 3061 ac = 12.39 km<sup>2</sup> nearly 40% of which is Industrial
- Tax contributions - 54% renters and 45% owners
- # Businesses in BIAs: 145 Barton Village; 128 International Village; 103 Ottawa St

- **Consulted** on operational matters in Ward
- Responsible for stewarding **Ward funding**

- \$5,324,750 in 2022 > **\$5,723,170** currently + future years at ~\$1.5m
- Community grants program > **\$175,000**
- Successful grants - Central, Corktown, and North End Neighbourhood Associations, Central Presbyterian Church, gritLIT Literary Festival, Hamilton Community Peregrine Project, Sexual Assault Centre Hamilton and Area (SACHA), Supercrawl Productions

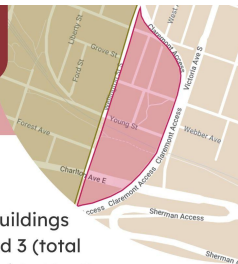

### Facts about Stinson

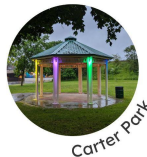
- 1 Neighbourhood Park - Carter Park

# 2022-23 Impact Report



- **By the Numbers - Ward 3 Office**
  - **80.25%** global reply & resolution rate to residents
    - 12,000 emails received in 2023
    - 5750 short and long term casework files
    - 840 phone calls responded to
  - Hosted **17** community meetings, including **7** Pop-Ups
  - Published **19 E-Newsletters** to 1346 recipients
  - Social Channels
    - IG 4800+ followers, 434 new
    - Av 30 posts/month, Av 2625 likes/engagement a month on posts
